**★ THE LOCATION OF THE POOL SHALL ADHERE TO THE FOLLOWING MINIMUM SETBACKS ★
★A DETAILED SITE PLAN IS REQUIRED★**

- 5 ft from walls, landscaping elements or structures, trees and other appurtenances.
- 10 feet linear and 18 feet diagonally distant from electrical service lines.
- 10 feet from principal or accessory structures, excluding decks. This means a deck may surround a pool however, the distance from the house/garage/accessory structure or any overhang must be at least 10 feet.
- Property and building line setbacks as stipulated in the Zoning Ordinance, by zoning district.
 - A-1: 15 ft. from side property line and 15 ft. from rear property line.
 - A-2: 15 ft. from side property line and 15 ft. from rear property line.
 - RR: 15 ft. from side property line and 15 ft. from rear property line.
 - R-1: 15 ft. from side property line and 15 ft. from rear property line.
 - R-2: 5 ft. from side property line and 5 ft. from rear property line.
 - R-3: 10 % of lot width with a 5 ft. minimum and 15 ft. maximum from the side property line and 5 ft. from rear property line.
